EARLY DISMISSAL STUDENT FORM**

Due to severe weather or other emergencies (such as loss of public utilities), the school district may find it necessary to dismiss school before the normal scheduled time. Parents/guardians should develop a plan for this possibility, so that students and their schools know what to do. Such plan should include an alternative/back-up plan in case the first plan cannot be implemented.

Please complete the form below which will inform your child's school of the emergency-school-closure-plan that you have discussed with your child. A form needs to be completed for each child, so that each of their appropriate teachers will have this information available to them. Parents/guardians are responsible for ensuring that their child's school has updated information on this form.

If an emergency closing occurs during the school day, the local media will communicate this closing as soon as possible. It is likely that many parents/guardians will not know this condition exists. We strongly encourage families to listen to the radio when the weather is inclement. Parents/guardians always have the right to keep their children at home if there is a safety concern.
